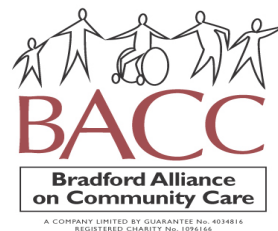
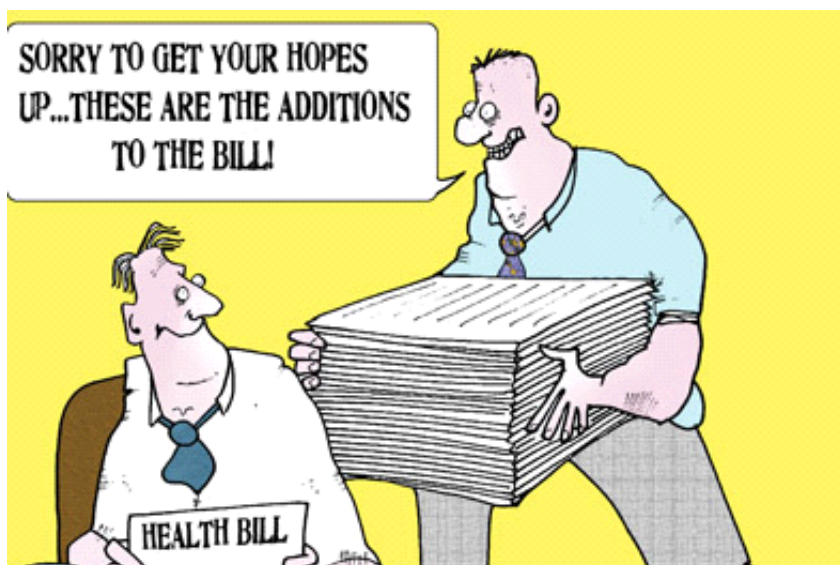

BACC July Open meeting to discuss commissioning policy for disabled adults

The draft strategic document of Adult Services and Bradford & Airedale NHS, 'Independence, Inclusion and Support' declares a vision of:

"Bradford as a district where people with physical and sensory disabilities live, work and participate in their local community."

"Where those individuals are recognised as equal and can enjoy the same life opportunities, chances and rights as their non-disabled peers and neighbours."

The document goes on to assert—"This vision through ensuring services, facilities; individuals; communities and society are truly inclusive and accessible; not extraordinarily or exceptionally but universally and ordinarily."

BACC will host a discussion on Wednesday 6th July on this policy document that will underpin the basis of the service commissioning and associated policies for the district of Bradford in the coming years. This will be an opportunity for people who use services & the projects that work with them to comment on the draft strategy through round table discussions, including looking at the commissioning priorities and giving an opportunity to feed in the issues that are most important to them.

The need for disabled people to comment in the climate of the current spending cuts being made by both NHS and local authority commissioners is obvious. But perhaps the document could be clearer in declaring the big objectives to be aspirations not a set of rights or entitlements.

The document is some 42 pages in length and covers the underlying challenges Bradford District faces in addressing the vision statement (on page 1).

How well people understand the terminology used in the document and its implications remains to be seen. For example how the phrase “care -pathway across all long term conditions” is understood by individuals and for that matter, representative, campaigning and lobbying groups is not necessarily the same interpretation as that held by public health policy professionals who wrote the policy.

BACC was convinced in common with many of the leading national charities that how the individual disabled person makes the journey through health, social care or housing support services would be aggravated by the proposals of the first draft of the NHS & Social Care Bill with its emphasis on competition being the central focus.



How and what changes will occur to that Bill remain unclear, as are the affects of these changes on the strategic policy. What will be the impact of changes to access independent advice services on the lives of individuals? How will this fit with the aspirations of the strategic policy?

These and many more questions will be debated with policy officers, disabled people and service providers at the event. Your views will be fed into the final strategy—this stage of the consultation closes on the 15th July. BACC will circulate a report from the meeting with the next edition of BACC Page. 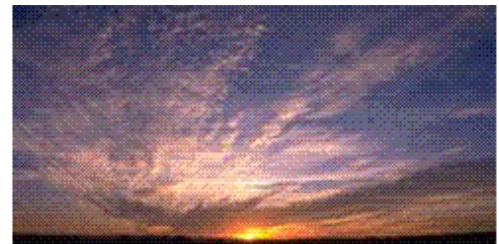

This aims to set the blueprint for how older people's services in Bradford and Airedale are developed in the future. Disabled People's Forum responds to Shipley MP's comments on disabled people and employment.



Dear Friends

Equal pay for equal work has been a campaign slogan for many years. Recent statements by a local MP demands we restate the justice of the slogan 'equal pay for equal work.'

Philip Davis MP appeared to imply that a disability means a lesser work value is offered by disabled people to employers.

The evidence of the work BACC and others carried out under the programme "EmployDisability" tells a very different story to the assertions of the MP. The local Adult Services & NHS Bradford & Airedale draft policy "Independence Inclusion & Support" lists as a priority improved opportunity for disabled people to have employment not as second class workers but to ensure that individuals "***are recognised as equal and can enjoy the same life opportunities, chances and rights as their non disabled peers and neighbours***".

Perhaps Mr Davis MP will take time-out to hear the voice of disabled people at either the consultation event on 6th July or at the Disabled People's Forum celebration event on 20th July 2011?

Future Forum Report Welcome, But Government Should Go Further



National Voices

National Voices (The voluntary sector organisation that represents the voice of people with a diverse range of health conditions, for more info see www.nationalvoices.org.uk) has welcomed the NHS Future Forum report and urges the government to accept the recommendations and, in some cases, to go further.

This report embodies many of the principles and actions that our members – over 100 health and social care charities - have been calling for on behalf of service users.

Points in the report that National Voices particularly welcomes include:

A focus on the NHS constitution – a landmark statement of rights, signed by National Voices

The importance of integration of care services

The principle that “no decision about me without me” should be hard wired into every part of the system”

Independent members of commissioning consortia would protect against conflicts of interest

A strong Health Watch England, with a Citizen's Panel, would give patients and citizens a strong voice at national level

Areas where more work will be needed by government:

Ensuring the independence and adequate funding of local HealthWatch

Giving patients and patient organisations a stronger role as part of the range of experts in commissioning

Further emphasis on safety, quality and dignity and on learning the lessons from Mid Staffordshire, Winterbourne View and those in the recent Ombudsman's report on care of the elderly.

Addressing some of the big challenges ahead such as the funding of social care.
